## Concept

### Background

At a time when Europe is still reeling from the aftermath of a pandemic, war at its borders, the ongoing cost of living crisis, and political instability, its Roma find themselves facing worsening poverty and exclusion, dire living conditions, and widespread antigypsyism every day.

**Ensuring access to decent and sustainable employment** is a key dimension of the EU Roma Strategic Framework, a focus of multiple principles of the European Pillar of Social Rights, and also supported by the Sustainable Development Goals. And yet, only 43% of Roma are in paid employment, while those who do work are overrepresented in low-paid and precarious jobs, and underrepresented in trade union structures. Antigypsyism continues rampant in recruitment as well as the workplace, so many Roma turn to informal work to make ends meet.

With the adoption of the **EU Roma Strategic Framework** up to 2030, Governments developed National Roma Strategic Frameworks in EU Member States and Western Balkan countries in 4 thematic areas and 3 horizontal strategic objectives, including education, employment, health, housing, fighting antigypsyism, combating poverty, and promoting Roma participation. In order to ensure an effective implementation of the ensuing National Frameworks, a robust and continued monitoring of the entire policy process should be ensured.

### Objectives

The **first part of the event** will serve to launch ERGO Network's research report on "**Roma access to decent and sustainable employment**", based on six national case studies carried out in Bulgaria, the Czech Republic, Hungary, Romania, Slovakia, and Spain, with additional benchmarking from Ireland. A dialogue with key decision-makers and stakeholders will aim to identify positive solutions to support better labour market inclusion for Roma, and to inform the delivery on the EU Roma Strategic Framework, the Social Pillar, and the SDGs.

The **second part of the event** will provide insights into the next steps for the EU Roma Strategic Framework on Equality, Inclusion, and Participation and the corresponding Council Recommendation, in the context of a new European Parliament and European Commission. The session will look at both EU Member States as well as enlargement countries, and a particular focus shall be placed on **combatting antigypsyism as a key cross-cutting priority** of the Framework, including the extensive work done in the context of the Roma Civil Monitor project.

### Participants

The conference will bring together ERGO Network members from the grassroots level, EU policy-makers from across the institutional spectrum, as well as other relevant European and national stakeholders. The event will also be fully live streamed on our Facebook page.
